
- (i) Obtain approval of your student's pass (if applicable to you);

All international students at MDIS are required to undertake the <u>Urine Drug Test</u>, in addition to the Basic Medical Test (HIV screening and Digital Chest X-ray). Fees of these tests are included in the Non-Tuition Fees. The Urine Drug Test will detect the following: Phencyclidine, Cocaine, Amphetamines, Tetraydrocannabinol (THC) and Opiates. The Urine Drug Test <u>must be done in Singapore</u>.

International students who do not pass the Drug Test will be withdrawn from MDIS and their Student's Pass Approval with ICA will be cancelled.
